: DRILLING OF TEN INCHES DIAMETER (10"Ø) DEEPWELL WITH AN APPROXIMATE DEPTH OF EIGHTY (80) MÉTERS WITH STAINLESS SCREEN using Rotary Drilling Method, furnishing and installation of 250 mmØ x 6m spiral welded casing, gravel packing, cement

grouting and other related miscellaneous works

Bids received in excess of the ABC shall be automatically rejected on the bid opening. Bidders should comply with Section 23.5 of the Revised IRR of RA 9184. The description of the eligible bidder is contained in the Bidding Documents, particularly in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184), otherwise known as the "Government Procurement Act".

Interested bidders may obtain further information from the City of Ilagan Water District and inspect the Bidding Documents at the address given below from 8:00 A.M. -5:00 P.M., Monday to Friday.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of non-refundable fee in the amount of Five Thousand Pesos (Php5,000.00). Only those who have purchased the bidding

documents shall be allowed to participate and raise or submit written queries or clarifications pursuant to Section 22.3 of the Revised IRR of RA 9184.

Bids must be submitted on or before **December 10**, **2020 at 12:00 NN** to the address given below. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The CIWD – BAC will hold a **Pre-Bid Conference on December 3, 2020 at 2:00 P.M.** which shall be open only to all interested parties who have purchased the Bidding Documents.

Prospective Bidders should have the following minimum qualifications to be considered eligible to bid: (a) Must be a duly registered Well Driller by the National Water Resources Board (NWRB) and must possess an authentic Certificate of Well Driller Registration issued by the NWRB, valid for the current year; (b) Must have an extensive expertise in water well drilling for at least ten (10) years and should have a Philippine Contractors Association Board (PCAB) License with the Well Drilling Work.

The City of Ilagan Water District reserves the right to accept or reject any bid, to annul the bidding process and to reject all the bids at any time prior to the contract award without incurring any liability to the affected bidder or bidders.
